HEAVY DUTY CLEANER CONCENTRATE

TRAINING INSTRUCTIONS:

USE:
This environmentally preferred, high performance cleaner concentrate was especially formulated to remove grease from hoods, floors, and other greasy buildup. **NOTE: Will remove a wax finish.**

DIRECTIONS:
Mix 15 ounces of this product with 113 ounces of cold water to yield one gallon of ready to use cleaner. This ready to use product may then be used in a trigger spray application, mop bucket or with a sponge/rag application. Apply liberally, allow some dwell time, then wipe or remove residue with squeezed damp mop. No rinse is required. **NOTE: Improper use or dilution may result in damage to surfaces and increase the risk of human health effects**

RECYCLABLE PACKAGE:
This package can be diverted from the waste stream through available processes and programs, and can be collected, processed, and returned to use in the form of raw materials of products.

HAZARD STATEMENTS: Causes eye irritation.

PRECAUTIONARY STATEMENT-PREVENTION:
Wash face, hands and any exposed skin thoroughly after handling. Avoid release to the environment.

PRECAUTIONARY STATEMENTS-RESPONSE:

FIRST AID MEASURES:

NOTE TO PHYSICIAN:
Product is a corrosive material. Use of gastric lavage or emesis is contraindicated. Possible perforation of stomach or esophagus should be investigated. Do not give chemical antidotes. Asphyxia from glottal edema may occur. Marked decrease in blood pressure may occur with moist rales, frothy sputum, and high pulse pressure. Treat symptomatically.
